

Tap the blue “hand” icon  to compose and submit a question. Management will make every effort to answer your question. If you are participating via telephone, there are scheduled times during and at the conclusion of the meeting when phone lines will become unmuted for participants to ask their question. Questions and answers will be posted to the CXI website Investor Relations page after the meeting.

If a new proposal is tabled during the webcast, voting forms will pop up automatically for registered shareholders only which will be counted as a ballot. You can vote by clicking “For”, “Against” or “Abstain”. In the event that you do not see a vote pop up, please click on the Active Poll button  to check if voting is still open.

Only ballots of Shareholders or Appointees will be counted. The vote remains open until the Chair closes the poll. Those participating via telephone will be prompted to cast their ballot via the selection of a button. (Ex. Press 1 for “For”; 2 for “Against” and 3 for “Abstain”).

Messages from Management will be pushed through this icon.
